The Purpose of the NMACTE Fellowship Program is to:

- Provide an opportunity for CTE Educators within New Mexico to further the development of their leadership skills; gain a deeper understanding of each state's CTE structure, history, funding, and delivery of training; and to increase participation in CTE events within our state, Region IV, and the nation.
- Allow CTE leaders to gain an understanding of our structure, committees, budget, leadership, and opportunities for involvement.
- Support the development of CTE leaders that will continue to serve as state, regional, and national ACTE leadership.

PROGRAM OF WORK

- Fellowship program that will culminate at the annual NMACTE conference
- Attend monthly zoom meetings with the Fellowship Coordinator(s) and other Fellows
- Read a leadership development book and participate in monthly discussions
- Interact monthly with a selected state CTE mentor
- Opportunity to attend a state CTE conference, outside of Fellow's current state
- Attend the ACTE Vision Conference (recommended)
- Attend the NMACTE Annual Conference (required)
- Participate in a Region IV Conference & Policy Meeting, if possible.
- Work with state CTE leadership to coordinate the state overview zoom meeting
- Develop a Fellows' presentation for the NMACTE and/or Region IV Conference
